Indoor Advantage Gold is based on established, non-proprietary, open, consensus-based standards and test methods. It employs objective sampling and testing criteria—samples are selected using an objective and transparent scientific process.

#### No conflict of interest with testing laboratories

- SCS only uses independent, ISO/IEC 17025 accredited laboratories globally located.
  - Asia (TUV Hong Kong), North America (BAA CA, MAS GA, Intertek MI), Europe (eco INSTITUT -Germany, Eurofins – Denmark)
- All independent labs must be audited and approved by SCS.
- Testing consistency is verified by SCS through intra-laboratory blind sample testing.
- There is no financial stake in approved laboratories; therefore, there is never undue pressure to skew results or require unnecessary testing.

## Objective and experienced auditors

- Lead auditors are certified and trained to ISO 90001.
- Auditors are based in China, United States, Mexico, and Europe.
- Auditors use risk-based auditing criteria to fulfill onsite auditing requirements.



## **Transparency and Disclosure**

SCS is a recognized global leader in third-party certification for environmental sustainability claims and utilizes scientific, non-proprietary standards. These standards were developed using an ANSI open, consensus-based process and a consortium of stakeholders that include NGOs, consumer interest groups, academia, and industry members.
